Karin,

I will say this. Susan never saw me that much because I avoided her. I snuck into the house, via my private entrance, I kept to myself in my room, door closed, and would travel into the living room when she was downstairs in Jay's apartment or away. Susan would go off on one of her "tirades" almost every night, screaming and shouting in the common areas and her bathroom; she is volatile, as you well know, and you can never predict her mood. But I was home. Whenever I was going to be out of town, it was with her permission that she watch the animals. I never neglected them. I never left without any notice.

Susan loved feeding the rabbits carrots, this is true. When I came home after work I would check the water and food dish to make sure they had food - when it was low, I filled it. Sometimes Susan would do it before I got home, sometimes not.

Susan also fed Toby wet food and human food, which I asked her repeatedly not to do. I would come home and feed Toby, only to find out that she had already fed him food that wasn't healthy for his weight.

I'm sorry that you went on the advice/word of Susan because everything you both are claiming about me is false. It is defamation of character and I don't appreciate it. I love Toby with all of my heart and I would never neglect him. I was moving to DC to 1) get away from Susan and the stressful situation of her home and 2) be closer to work so that I would have a shorter commute and more time to spend with Toby. You and Susan are in no position to judge others and the care that they give their pets. If you had any problems with me, you should have contacted the Humane Society. You did not. You put him up for adoption and stole him, plain and simple. I called your house the night of his dissapearance and you lied to me, saying that you didn't know where Toby or Susan was. When I went to your house the following evening, you lied again. You have been caught in your lies and it is very unfortunate for you.

When you get Toby back I am willing to get them one either through adoption or purchase. Kristina, I hope you can forgive me. I really was very very stupid. I did believe that you were giving him up and I did believe Susan about your neglect. PLEASE let me know what you think I can do to right, to the degree possible, the situation.

Kristina, you were gone all the time. I have a number of witnesses to verify that reality, and the reality that I was left to care for Toby in your absence, which was pretty constant. I also have neighbors who will testify that they were ready to call the Humane Society because Toby barked desperately late into the night.

The fact is I fed him—because you'd go out on dates late into the night, if you came home at all. He slept in my bed throughout the summer, and for big chunks of the winter & spring. You'd go out for days at a time, and wherever you were, Toby was not part of your plans. He was aching for your attention, Kristina. He was just desperate for contact with anyone—and numerous times, you yourself said that Toby wanted to be part of my family,

Don't mistake what's going to happen, Kristina. If you take this to court, I will be alleging abandonment. I will call witnesses to verify that abandonment. And I will sue to get Toby back from you so that I can return him to that excellent home in Maine.

As for your comments, I'm not your mother. I'don't need you to "check in with me" when you come & go from the house. I did not require that you should have any contact with me whatsoever.
